RE: Coastal Zone Consistency for Corps Reference # 2019-00259, Pura Vida Residence, Seattle, King County, Washington

Dear Paul R. Wanzer:

On October 26, 2020, The Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the replacement of an existing single-family floating home legally established in a conforming private moorage on Portage Bay with a new floating home. The project also includes replacing the existing impervious walkway with a pervious floating walkway, the addition of two new steel piles to secure the new floating home, and removal of one existing wood pile and several floating logs. The new floating home would be constructed off site, the existing home demolished, and the new floating home towed into the location of the existing home. These improvements would be located at 3240 Portage Bay Place East, Seattle, Washington in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Paul R. Wanzer's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
