On February 6, 2020, Chelsea Farms submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Lewis Shellfish Beach, Thurston County, Washington. The Department of Ecology (Ecology) issued a public notice for the project on February 12, 2020. The U.S. Army Corps of Engineers (Corps) issued a joint public notice on February 27, 2020, with an Erratum issued on August 11, 2020.

The proposed project is to install a commercial geoduck aquaculture operation on 0.75 acres of a 1.16 acre tideland parcel between +1.0 and -4.5 Mean Lower Low Water (MLLW) tidal elevations. Work will occur by hand with access to the tidelands by boat. No access will occur from uplands. Cultivation will entail placing the geoduck seed within PVC anti-predator tubes (4-inch diameter by 10-inch length) at a density of one tube per square foot on the tidelands. Each tube will have a mesh cap secured with a rubber band resistant to UV light and salt water. The area is then covered with netting comprised of 40 ft. by 40 ft. squares (3-inch or smaller stretched mesh). The netting is secured to the sand with 24-inch u-shaped rebar, spaced every five feet around the perimeter. Planting may occur at low tide in the "dry" or at high tide in the "wet".

Between 6-12 months after planting, the caps and bands can be removed from the tubes; at 18-24 months, the tubes and netting can be removed from the site. The geoducks will be harvested at about 5-7 years using low-pressure water pumps with a "stinger/wand" with nozzle pressure to liquefy/loosen the sediment so that the geoduck can be removed by hand. Harvest occurs at low tide, or by divers at high tides.

The project site is located on tidelands within Eld Inlet, on parcel number 93019300000 adjacent to 7435 Cooper Point Road, near Olympia, Thurston County, Washington; Section 16, Township 19, Range 2 West; WRIA 13, Deschutes Watershed.

With this Order, Ecology is granting Chelsea Farms' request for a Section 401 Water Quality Certification for the Lewis Shellfish Beach project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request Ecology received on February 6, 2020, and the following supporting documentation:

- 1. E-mail letter to Ecology dated January 11, 2021, regarding compliance with the conservation measures associated with the "Programmatic Biological Opinions for Shellfish Activities in Washington State Inland Marine Waters" (U.S. Fish and Wildlife Service (USFWS) Reference Number 01EWFW00-2016-F-0121, National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502).
- 2. E-mail letter to Ecology dated January 19, 2021, regarding water quality monitoring.
- 3. E-mail to Ecology dated January 26, 2021, regarding compliance with the 2019 Puget Sound Shellfish Growers Association Environmental Codes of Practice for Shellfish Aquaculture.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Chelsea Farms must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Chelsea Farms to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for actual spills to water only.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Chelsea Farms, Lewis Shellfish Beach project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues a permit for this project. Order No. 19582 will remain in effect for a period of fifteen (15) years from the date of issuance.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within 30 days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
