RE: Coastal Zone Consistency for Corps Reference #NWS-2020-582, Meydenbauer Hill Pier and Beach Cove Project, Bellevue, King County, Washington

Dear Vahé Torossian:

On December 14, 2020, the Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This decision is for the following activities: removal of an existing 684-square-foot pier; demolishment of an existing 287-square-foot boat cover, construction of a new 575-square-foot pier, installation of a new 144-square-foot platform lift and boat lift, removal of 30 lineal feet of existing bulkhead, creation of a beach cove, and native vegetation planting. The project is located at 9553 NE Lake Washington Boulevard NE, in Bellevue, Washington, in King County.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Meydenbauer Hill, LLC's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You have a right to appeal this decision to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this decision. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do all of the following within 30 days of the date of receipt of this decision:

• File your appeal and a copy of this decision with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.

• Serve a copy of your appeal and this decision on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.
