Dear Kyle Lentz:

On December 11, 2020, The Department of Ecology received a Certification of Consistency with the Washington State Coastal Zone Management Program (CZMP) for the above project.

This determination is for the 2 Chelsea Farms Manke project to continue to commercially cultivate up to 3.16-acres of geoduck clams, 5.17-acres of manila clams, and approximately 2-acres of oysters in bags over a 12.91-acre project area (10.33-acre cultivation area) within the intertidal zone of Eld Inlet, South Puget Sound, Thurston County, Washington.

This project site is located on tidelands within Eld Inlet, on parcel numbers: 12917340106, 12917340101, 12917340105, 12917340102, 93020700000, adjacent to 6818 Young Road NW, Olympia, Thurston County, Washington; Section 17, Township 19, Range 2 West; WRIA 14, Kennedy – Goldsborough Watershed.

Pursuant to Section 307(c)(3) of the Coastal Zone Management Act of 1972 as amended, Ecology concurs with Chelsea Farm's determination that the proposed work is consistent with Washington's CZMP.

YOUR RIGHT TO APPEAL

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
