On July 8, 2020 Wiegardt and Sons Inc. submitted a request for a Section 401 Water Quality Certification (WQC) under the federal Clean Water Act for the Wiegardt Shellfish Stackpole DNR Lease, Pacific County, Washington. The Department of Ecology (Ecology) issued a public notice for the project on October 22, 2020.

This project proposes to continue operation of 94.07 acres of on bottom oyster culture. On bottom oysters are produced through hatchery-produced seed. Hatchery-produced seed is planted after the mature oysters have been removed. Oysters are harvested every 1 to 3 years depending on oyster density and growth. 45 acres are dredge harvested each year. Hand harvest at low tide also occurs. This project is not proposing any harrowing, frosting or graveling.

The project site is located on tidelands within Willapa Bay on DNR Lease Nos. 20-013269, 20-A12806, 20-A12056, and 20-A12914, near Ocean Park, Pacific County, Washington; Section 21, 22, 23, 26, and 27, Township 13N, , Range 11W; WRIA 24, Willapa Bay Watershed.

With this Order, Ecology is granting Wiegardt and Sons Inc.'s request for a Section 401 Water Quality Certification for the Wiegardt Shellfish Stackpole DNR Lease project, provided that the activity is conducted in accordance with the Section 401 Water Quality Certification request and attachments Ecology received on July 8, 2020, and the following supporting documentation:

1. E-mail letter to Ecology dated February 12, 2021, regarding the project's compliance with the conservation measures associated with the "Programmatic Biological Opinions for Shellfish Activities in Washington State Inland Marine Waters" (U.S. Fish and Wildlife Service (USFWS) Reference Number 01EWF00-2016-F-0121, National Marine Fisheries Service (NMFS) Reference Number WCR-2014-1502). This email also includes a description of Wiegardt and Sons Inc.'s water quality monitoring plan.

Based on the information submitted, Ecology has determined that the discharge from the project will comply with state water quality requirements. Prior to undertaking any changes that materially alter the project, Wiegardt and Sons Inc. must contact Ecology to determine whether a new Section 401 Water Quality Certification is required.

Issuance of this Section 401 Water Quality Certification for this proposal does not authorize Wiegardt and Sons Inc. to exceed applicable state water quality standards (Chapter 173-201A WAC), ground water quality standards (Chapter 173-200 WAC) or sediment quality standards (Chapter 173-204 WAC). Furthermore, nothing in this Section 401 Water Quality Certification absolves the Applicant from liability for contamination and any subsequent cleanup of surface waters, ground waters, or sediments resulting from project construction or operations.

Any work that causes distressed or dying fish or discharges of oil, fuel, or other chemicals into state waters or onto land with a potential for entry into state waters is prohibited. If such work, conditions, or discharges occur, immediately notify Ecology's Regional Spill Response Office at 360-407-6300 and the Washington State Department of Fish & Wildlife with the nature and details of the problem, any actions taken to correct the problem, and any proposed changes in operation to prevent further problems. You will also need to notify the Washington Emergency Management Division at 1-800-258-5990, for actual spills to water only.

In view of the foregoing and in accordance with 33 U.S.C. §1341, RCW 90.48.120, RCW 90.48.260 Chapter 173-200 WAC and Chapter 173-201A WAC, this WQC is granted to the Wiegardt and Sons Inc., Wiegardt Shellfish Stackpole DNR Lease project.

This Certification is not effective until the U.S. Corps of Engineers (Corps) Seattle District issues an individual Department of the Army (DA) permit for this project. Order No. **19735** will remain valid for the duration of the associated permit. Wiegardt and Sons Inc. should send a copy of the final DA permit to fednotification@ecy.wa.gov within two weeks of receiving it.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within 30 days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
