

**Public Notice of Applications for State of Washington

**1. Project Name:** Antoine Creek Culvert Replacement

**Applicant:** Chelan County Flood Control Zone District

**Project Location:** Adjacent to 560 Antoine Creek Road, Chelan, Chelan County.

**Project Description:** As a result of the high severity burn of the wildlife within the Antoine Creek basin, the discharge and velocity of surface water flows have substantially increased over the last several spring runoff events. Replace three culverts (two 24-inch diameter corrugated metal pipe culverts and a 36-inch) adjacent to and under Antoine Creek Road. At each locations, a WDFW approved 3-foot tall by 8-foot wide box culvert will be installed with varying lengths at each location.

**2. Project Name:** Middle Entiat Habitat Improvement - Cottonwood Flats RM 17.5 - 17.8

**Applicant:** Chelan County Natural Resources

**Project Location:** Entiat River Rd, Entiat, Chelan County.

**Project Description:** Restore Hydraulic connectivity between the Entiat River and its floodplain, to improve instream habitat for salmonids, and to restore wetland function in the floodplain.

**3. Project Name:** Doane Bulkhead Replacement

**Applicant:** Doane, Sheila

**Project Location:** 9015 SW Summerhurst Road, Vashon, King County.

**Project Description:** Replace the existing failing creosote and pressure-treated timber bulkhead with an angular rock bulkhead in order to protect the existing residential structures and infrastructure in the least impactful way.

4. **Project Name:** Luther Burbank Park Irrigation Intake and Swim Area Maintenance  
**Applicant:** City of Mercer Island Parks and Recreation  
**Project Location:** 2040 84<sup>th</sup> Avenue Southeast, Mercer Island, King County.  
**Project Description:** Install a new irrigation intake system and maintain an existing swim area as part a comprehensive maintenance project on the shoreline of Lake Washington at Luther Burbank Park on the north end of Mercer Island.

5. **Project Name:** South Dock Repair  
**Applicant:** Seattle Iron and Metals Corp.  
**Project Location:** 601 South Myrtle Street, Seattle, King County.  
**Project Description:** Repair and maintenance activities that are required to ensure continued operations of the south dock. The existing timber decking with asphalt overlay and supplemental metal plating will be replaced along a majority of the dock, and will be repaired as needed in the southern portion of the dock.

6. **Project Name:** Cousins Road Culvert Replacement – CMP 1502  
**Applicant:** Lewis County Public Works  
**Project Location:** Cousins Road at Mile Post 3.15, Chehalis, Lewis County.  
**Project Description:** Replace an existing 4-foot high by 6-foot wide corrugated metal pipe arch 36 ft in length with a 30-foot wide by 1.5-foot tall by 45-foot long precast voided slab girder bridge.

7. **Project Name:** North Kentuck Trails Road Bridge 4205 Scour Repair – C3240  
**Applicant:** Spokane County Public Works  
**Project Location:** City of Spangle, Spokane County.  
**Project Description:** Restore armoring at the face of the south abutment and provide bank stabilization upstream of the abutment. This includes removing existing material and replacing it with appropriately sized rock for erosion and scour protection.

8. **Project Name:** Bellingham Cruise Terminal Maintenance and Repairs  
**Applicant:** Port of Bellingham  
**Project Location:** 355 Harris Avenue, Bellingham, Whatcom County.  
**Project Description:** Repair damaged and deteriorated structural components as part of routine facility maintenance.
