- 1. Project Name:** King County Harbor Island Dock Demolition  
**Applicant:** King County Solid Waste Division  
**Project Location:** 3235 16th Ave SW, Seattle, King County.  
**Project Description:** Remove of an approx. 72,700-sq-foot creosote-treated derelict timber dock structure, including its ancillary components, and shoreline stabilization work to stabilize the site once the derelict dock and associated components have been removed.

- 2. Project Name:** Vigor Fenderpile  
**Applicant:** Vigor Industrial LLC  
**Project Location:** 1801 16th Ave SW, Seattle, King County.  
**Project Description:** Maintenance to their existing facility by replacing fender piles. Maintenance would occur on Piers 3, 4, 5, and 6. Vigor would replace up to 248 fender piles with a maximum of one-hundred piles per year, over a ten-year period.

- 3. Project Name:** Lucas Creek Road MP 4.2 and 4.3 Culvert Replacement - CMP 1803  
**Applicant:** Lewis County Public Works  
**Project Location:** Lucas Creek Road MP 4.2 and 4.3, Chehalis, Lewis County.  
**Project Description:** Replace culverts on two separate unnamed tributaries to Lucas Creek. Replace an existing 3-ft diameter corrugated steel pipe by 33-ft in length and replace an existing 6-ft x 4-ft corrugated steel squash pipe by 66-ft in length, located on Lucas Creek Road at MP 4.2 and 4.3.

4. **Project Name:** Pleasant Valley Road Bridge MP 2.46  
**Applicant:** Lewis County Public Works  
**Project Location:** Pleasant Valley Road MP 2.46, Adna, Lewis County.  
**Project Description:** Repair the scour beneath Pleasant Valley Road Bridge No. 161. This includes the removal of existing material beneath the bridge, the insertion of controlled density fill below the northern bridge footing, and placement of A-Jacks within the channel below the bridge as well as along the banks.

5. **Project Name:** Skagit DID 14 - Drainage Maintenance Agreement and Plan  
**Applicant:** Skagit County Drainage District 14  
**Project Location:** Skagit County.  
**Project Description:** Conducts routine maintenance of drainage infrastructure within the jurisdictional boundary of Skagit County DID 14 consistent with the provisions and elements of the district's Drainage Maintenance Agreement and Drainage Maintenance Plan.

6. **Project Name:** Idaho Road Bridge Replacement  
**Applicant:** Spokane County  
**Project Location:** Town of Fairfield, Spokane County.  
**Project Description:** Remove and replace the super structure of the bridge and adding additional piling to reinforce the existing deteriorated timber piles.

7. **Project Name:** Meadow Creek Ranch – Farm Road Culvert Replacement  
**Applicant:** Meadow Creek Ranch LLC  
**Project Location:** 17211 S Brooks Rd, Cheney, Spokane County.  
**Project Description:** Replace two failing metal culverts (approx. 32 inches and 36 inches in diameter) on an existing farm road that crosses Hog Canyon Creek.

8. **Project Name:** Phillips 66 West Turnaround Contractor Parking Lot  
**Applicant:** Phillips 66 Company Ferndale Refinery  
**Project Location:** 3901 Unick Rd, Ferndale, Whatcom County.  
**Project Description:** Construct parking lot in a vacant, mowed field within the Phillips 66 Ferndale Refinery property. The project would include a 4.2 acre gravel lot sized for approx. 500 parking spaces, a new 30-foot access driveway from Unick Rd for ingress and egress, fencing, security turnstiles, landscaping, and a filtration/bioretenion system for Stormwater treatment.

9. **Project Name:** Nelson Dam Removal  
**Applicant:** City of Yakima  
**Project Location:** City of Yakima, Yakima County.  
**Project Description:** The project consists of two phases. Phase I involves all work within and adjacent to the Naches River associated with dam removal, new intake construction, and fish passage and riverine process improvements. Phase II involves all work related to surface water conveyance improvements, including the installation of new surface water pipeline across Cowiche Creek.
