#### **Public comment invited**

The Washington Department of Ecology (Ecology) proposes removing the Environmental Covenant No. 201312260516 from the Jefferson Ave Site (Site). The Pierce County Auditor recorded the covenant on December 26, 2013.

We invite your comment on this proposal from **June 3 to July 6, 2021**.

Ecology will consider comments received during the comment period. If there are no significant issues raised during the comment period, Ecology will remove the covenant from the Site.

#### **Environmental Covenant**

An owner files a covenant on a property when contamination remains at a site after cleanup. The covenant restricts property use and protects human health and the environment. After cleanup at the Jefferson Ave Site, one small area has arsenic in groundwater above the state cleanup level. The covenant does not allow groundwater at the Site to be used for drinking.

#### **Background**

The Site is about three acres located at 2112-2122 Jefferson Ave in Tacoma.

In the past, houses, a gas station, automobile sales and repair, welding, steel fabrication, and a pest control company were located at the Site. The structures were removed in 2002.

After two underground storage tanks and a hydraulic hoist were removed, petroleum-contaminated soil and groundwater were detected above state cleanup levels. About 395 cubic yards of soil were removed and disposed of off the Site. In 2003, monitoring wells were installed to determine if groundwater was contaminated.

In 2012, results showed soil contamination was below cleanup levels. But arsenic in groundwater was above the cleanup level in one well. Ecology issued a No Further Action (NFA) letter in 2014 requiring a covenant be filed for the small area of the Site where the arsenic level was elevated.

Arsenic in groundwater was measured again in 2019-2020. The amount of arsenic had decreased over time, but remains slightly above the cleanup level in one well. The amount is low and it is below the state background level. Groundwater will not be used for drinking because the city supplies drinking water to the Site.

In 2021, it is Ecology's opinion that the covenant is no longer required, and the owner requested it be removed from the property.
