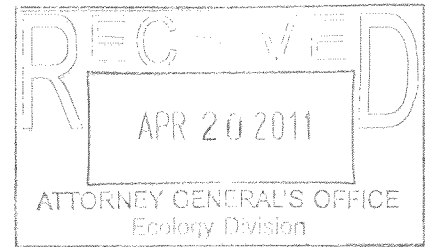

Dear Mr. Teel:

BOJO Investments, LLC, a dissolved Washington Limited Liability Company, is in receipt of the known claim by Washington State Department of Ecology dated March 3, 2011 for an amount up to \$4,243,125. The purpose of this letter is notify the Washington State Department of Ecology that such known claim is rejected due to insufficient funds pursuant to RCW 25.15.298 and RCW 25.15.300.

Enclosed please find a check in the amount of \$297,518.21 (TWO HUNDRED NINETY SEVEN THOUSAND FIVE HUNDRED EIGHTEEN DOLLARS AND TWENTY ONE CENTS), payable to Washington State Department of Ecology, representing all of the assets of BOJO Investments, LLC less \$50,000 (FIFTY THOUSAND DOLLARS) which is being withheld at this time to provide for the Company's other actual and potential expenses.
