

Amendment to Consent Decree Available for Public Comment

The Department of Ecology (Ecology) invites you to review and comment on a proposed second amendment to the consent decree for Leichner Brothers Landfill. The cleanup site, known as the Leichner Brothers Landfill site, is located at 9411 Northeast 94th Avenue in Vancouver.

Clark County now owns part of the site and is being added to the consent decree. The property transfer between Leichner Brothers Land Reclamation Corporation (LBLRC) and Clark County was recorded in December 2012. Both Clark County and LBLRC are now responsible for operation, maintenance and long term monitoring of the closed landfill.

A Consent Decree is a legal agreement between Ecology and one or more Potentially Liable Persons (PLPs) and recorded by a court in which the PLPs agree to do cleanup actions on a contaminated site.

Ecology Wants Your Comments

Ecology is accepting comments on the proposed consent decree amendment from January 24 through February 25, 2013. The box to the right shows where you can review documents and how to submit comments. Ecology will respond to comments received during the public comment period. We will then finalize the amended consent decree.

Site Background

From 1987—1996, LBLRC investigated and cleaned up the site. Investigations done during this time found that the landfill had contaminated the shallow and deep aquifer (groundwater) under the site. The company placed refuse in the landfill under a cap. The cap stopped direct exposure to the soil and prevented precipitation from seeping into the landfill.

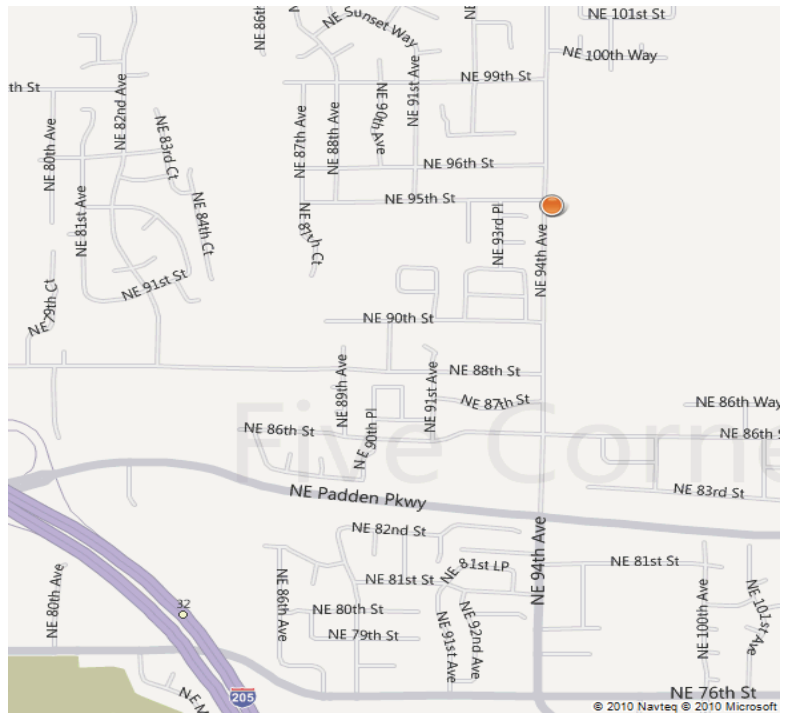
