Chevron Environmental Management Company (Chevron) is in receipt of the January 15, 2013 Determination of Potentially Liable Person Status letter for the above-referenced site. We understand and appreciate the Department of Ecology's interest in completing a timely cleanup of this site, and we apologize for any apparent delays to date.


As stated in our letter of October 31, 2012, Chevron respectfully challenges Ecology's PLP determination for this site, and we are currently working to prepare a supplemental response to support our position. Contrary to the information presented in your letter, our consultant, Russ Shropshire of SAIC, did contact your Central Records Department in December 2012 and made arrangements to review the files on January 10, 2013. That appointment was later rescheduled to January 16, 2013 due to Mr. Shropshire being ill. Following the review, SAIC received copies of the requested documents on January 30, 2013.

Chevron is reviewing the large volume of information produced by Ecology, all of which is relevant to Ecology's determination of Chevron's status as a PLP. For example, Ecology produced information pertaining to site investigation work, UST compliance efforts, and cleanup actions that occurred following the discovery of a new release at the site in May 2003. To provide Chevron sufficient time to review this large volume of information, Chevron asks that you honor our previous request, which was that Chevron be provided 30 days from receipt of Ecology's files to prepare its response. Chevron will respond on or before March 1, 2013.
