Ecology gave public notice of the tentative decision to issue the permit for corrective action and the draft agreed order for public comment on September 27, 2021. The public comment period ended on November 26, 2021. Three comments were received during the public comment period. The comments received did not result in any changes to the draft permit or to the agreed order.

This permit expires January 11, 2032. Pursuant to WAC 173-303-806(6), Burlington shall submit a new application for a final permit 180 days prior to this expiration date, unless Ecology grants a later date provided that such date is not later than January 11, 2032.

The agreed order is not appealable to the Pollution Control Hearings Board. The agreed order may be reviewed only as provided under RCW 70A.305.060.
