DEED NOTICE AND LAND USE RESTRICTIONS

Equilon Enterprises LLC dba Shell Oil Products US ("Shell") is the fee owner of certain real property located in Skagit County, Washington, as further described on Exhibit A hereto (the "East Land Treatment Facility") and certain real property located in Skagit County, Washington, as further described on Exhibit B hereto (the "West Land Treatment Facility").

Shell desires to give the notice pursuant to Section 173-303-610 of the Washington Administrative Code ("WAC"), to inform interested parties that:

- 1. The East Land Treatment Facility and the West Land Treatment Facility were once permitted RCRA Part B landfarms for managing petroleum wastes, which are considered "dangerous wastes" under WAC 173-303-040. A table of locations, types and amounts of dangerous wastes formerly handled in the bermed areas of the East Land Treatment Facility and the West Land Treatment Facility is attached as Exhibit C hereto.
- 2. A survey of the plat of both the East Land Treatment Farm and the West Land Treatment Farm and record of the type, location and quantity of wastes disposed of within the East Land Treatment Farm and the West Land Treatment Farm has been filed with the local zoning authority and with the Department of Ecology of the State of Washington, in accordance with WAC 173-303-610.
- 3. Use of the East Land Treatment Farm and the West Land Treatment Farm are hereby restricted under WAC 173-303-610 as follows: No redevelopment of the East Land Treatment Farm and the West Land Treatment Farm other than for access or industrial use shall be undertaken unless thirty days prior written notice has been given to the Department of Ecology (or any successor agency), and approval for such other use is given by the Department of Ecology (or any successor agency) in accordance with applicable laws. For purposes of this restrictive covenant, "industrial use" includes any industrial use allowed under the Model Toxic Control Act ("MTCA"), regulations promulgated under the MCTA and/or applicable zoning laws. Subject to the provisions of Section 4, the restrictive covenant in this Section shall run with the land, and shall bind current and future owners of any interest in the East Land Treatment Farm and the West Land Treatment Farm.
- 4. The current and future owners of the East Land Treatment Farm and the West Land Treatment Farm reserve the right, under WAC 173-303-610 (10), to remove the notation on the Deed Notice provided hereby with respect to the applicable property, and/or to add a notation to the applicable deed indicating the removal of

dangerous waste from East Land Treatment Farm and/or the West Land Treatment Farm as applicable. The owners shall have said right on the finding, approved by the Department of Ecology (or any successor agency or court with jurisdiction), that (a) the East Land Treatment Farm and/or the West Land Treatment Farm (as applicable) does not exceed MTCA Method B cleanup levels or, where appropriate, Method A cleanup levels, pursuant to WAC 173-303-610(2)(b); or (b) the restrictive covenant contained herein otherwise is no longer necessary or required by applicable law.






Exhibit B Legal Description West Land Treatment Facility




