Hi Jing,

On behalf of Chevron Environmental Management Company (CEMC), the following is a progress update for Chevron site 211577 ("Queen Anne") located at 631 Queen Anne Avenue North in Seattle, Washington. This update satisfies the requirements of Agreed Order No. DE 16537 associated with the site which indicates that quarterly progress reports be submitted to the Washington State Department of Ecology by the 10<sup>th</sup> of the month following the reporting period. This update summarizes activities completed from April 1, 2022 through June 30, 2022.

### **Description of Actions Taken to Comply with Agreed Order**

- Arcadis conducted indoor air and sub-slab vapor sampling at the Monterey and Del Roy Apartments April 6 and 7<sup>th</sup>, 2022
- Arcadis completed a utility locate to confirm the feasibility of installing wells at the locations proposed in the RIWP on April 6<sup>th</sup>, 2022.
- Arcadis submitted the ROW permit and is following up with Seattle Department of Transportation
- Arcadis has worked on securing access agreements for installation of wells as proposed in the RIWP

### **Summary of Deviations from Approved Work Plans**

- Based on the preliminary utility locate and site walk, the following changes were made to the Remedial Investigation Work Plan:
  - MW-40 moved to Monterey Apartments property; Bungalows Apartments property inaccessible.
  - MW-39 moved south to the parking lot of 601 Queen Anne Ave N; Bungalows Apartments property inaccessible.
  - MW-47 removed from scope of work. Alvena Vista Property has limited access and a gas line along the south side of the building, so there is no potential location for well installation.

### **Description of Work Planned for Third Quarter 2022 Reporting Period**

- Arcadis will continue to secure access agreements for installation of wells as proposed in the RIWP (with updated locations based on the April 6<sup>th</sup> utility locate). Access agreements are in progress for the following properties:
  - 601 Queen Anne Avenue North
  - 100 W Mercer Street
  - 118 W Mercer Street
  - 100 W Roy
  - 119 W Roy Street
- Arcadis will continue to prepare and submit quarterly updates to Ecology via email
