## Nidaamka nadiifintu wuxuu sameynayaa hormar

Waaxda Cilmiga Deegaanka (Department of Ecology) (Cilmiga Deegaanka) waxay kormeer ku sameynaysaa nadiifinta lagu sameynaayo Goobta Boathouse Inc Renton Skyway ee kutaala xaafada Skyway, oo ayna sameynayso GardnerGlobal, Inc (GG). Waaxda Cilmiga Deegaanka ayaa bixinaysa kharashka ku baxaaya nadiifinta ayagoo u maraaya Barnaamijkooda Deeqda ee lagu Nadiifiyo Guryaha Qiimahooda Jaban yahay (Affordable Housing Cleanup Grant Program). Barnaamijkaan wuxuu hubiyaa in goobaha "si sax ah loo nadiifiyey ayadoo kor loo qaadayo ka qaybgalka bulshada iyo hubinta nidaamka guryaha qiimahooda la awoodi karo."

Waxaan jeclaan lahayn inaan helno faalladaada ku saabsan dukumiintiyadaan soo socda:

- **Wareegtada Oggolaanshaha la xariirta Iibsadaha Mustaqbalka (Prospective Purchaser Consent Decree, PPCD):** Waa heshiish sharci ah oo u oggolaanaya iibsadaha inuu nadiifiyo goobta, uuna helo masuuliyada goobta.
- **Qorshaha Ka qaybgalka Dadwaynaha (Public Participation Plan):** waa dukumiinti sharaxaaya sida dadku oga qaybgeli karaan nidaamka nadiifinta.

## Taariikhda Aasaasiga ah

Xarunta Boathouse Inc. Renton Skyway (xarunta) waxay horey u ahaan jirtay bakhaar gada tafaariiqda iyo goob sameysa adeegyada nadiifinta qalalan waxayna ku taali jirtay Skyway, oo ah xaafad aan ka tirsaneyn maamulka King County, Washington. Hantidu waxay ku fadhidaa qiyaas ahaan dhul le'eg 0.48 acres waxayna ku taalaa aag ganacsi oo kamid ah xaafada.

Goobta adeegyada nadiifinta qalalan, Ken's Skyway Cleaners, waxay goobta ku shaqeynaysay laga bilaabo 1982 illaa 2002. Kiimikooyinka khatarta ah ee loo adeegsado ganacsiga nadiifinta qalalan ayaa wasakheeyey ciidda iyo biyaha dhulka hoostiisa kujira.

GG wuxuu kujiraa heshiiska iibinta iyo iska iibinta si dib loogu hagaajiyo Goobtaan loogana dhigo mashruuca Skyway Towncenter

(Mashruuca) mashruucan adeegyada kaladuwan, guriyeynta qoysaska badan ayaa yeelan doona arrimahaan soo socda:

- Qiyaas ahaan qaybo guud ahaan ku fadhiya dhul dhan 250
- Goob ugu yaraan leh 50 guryo oo ah guryaha qiimaha jaban (20% oo ah guud ahaan guryaha)
- 30,000 oo ah cabir laba jibaaran looguna talagalay ganacsi, xaafiis, iyo goob bulshadu ku kulmaan

Guryaha qiimaha jaban waxaa lagu heli karaa kiro waxaana kireysan kara 60%-80% dadka hela dakhliga dhexdhexaadka ah ee deegaanka (area median income, AMI). Dakhliga Dhexdhexaadka ah ee Deegaanka (area median income, AMI) waxaa sanad walba mar xisaabiya Waaxda Guriyeynta iyo Hormarka Magaalada (Department of Housing and Urban Development) ee Gobal walba. Naqshada loo dhisanaayo goobtaan ayaa la dooran doonaa ayadoo la adeegsanaayo rayiga bulshada iyo shaqada farshaxaniistayaasha deegaanka. ## Wasakhda

**Wasakhda saameynta ku yeelatay Biyaha dhulka ka hooseeya ayaa la xaqiijiyay inay ka jirto goobta iyo aagaga ku dhaw si loo nadiifiyo goobta. Inta ay le'eg tahay wasakhdu waxaa lagu oggaan doonaa baaritaanka sixida xogta. Ceelasha biyaha ee ka jira degmada Skyway Water District (oo ay isticmaalaan qiyaas ahaan 9,890 isticmaale) iyo City of Renton (oo ay qiyaas ahaan isticmaalaan 62,100 isticmaale) waxay ku yaalaan meel 2 mayl u jirta goobta.**

Baaritaanada waxaa lagu oggaadan wasakhdaan ciidda iyo biyaha dhulka ee soo socda:

- Kiimikada Biyaha (Tetrachloroethene, PCE)
- Kiimikada trichloroethene (TCE)
- Kiimikada cis-1,2-dichloroethene (DCE)
- Kiimikada vinyl chloride (VC)

Qiimaha saa'idka ah wuxuu shirkadaha guryaha dhisa ku keenaa inay helaan kaalmo yar si ay u dhisaan guryaha la awoodi karo.


Marka laga imaado khataraha la xariira dib u habbeynta, nadiifinta goobaha wasakhoobay waxay noqon kartaa hawlo adag oo leh khataro ay tahay in la tixgeliyo. Qiimaha iyo waqtiga ku baxaaya nadiifinta goobta badanaa fahan wayn lagama haysto; arrintaas oowgeedna, goobo badan ayaa la iskaga tabaa ayagoo maran ama aan la isticmaalin muddo sano ah, xataa marar muddo qarniyo ah. Taageerida nadiifinta lagu sameynaayo guryaha qiimaha jaban waxay gacan ka geysanaysaa hubinta in la sameeyo nadiifinta, iyo in la ilaaliyo caafimaadka bulshada iyo kan bii'ada.

Waaxda Cilmiga Deegaanka waxay sameysay Barnaamijka Deeqda Nadiifinta Guryaha Qiimaha Jaban (Affordable Housing Cleanup Grant Program, AHCGP) si uu gacan oga geysto kor u qaadista nadiifinta deegaanka gaar ahaan hormarka lagu sameynaayo guryaha qiimaha jaban. Intaas kadib, Wareegtada Oggolaanshaha la xariirta liibsadaha Mustaqbalka (Prospective Purchaser Consent Decree, PPCD) iyo Qorshaha Ka qaybgalka Dadwaynaha ayaa lasoo gabagabeyn doonaa, waxaana bilaabanaaya nadiifinta rasmiga ah. Baaritaan xog aruurin iyo Daraasad Wax ku ool ah ayaa la sameyn doonaa markaas kadib. Natiijada Baaritaanka xog aruurin iyo Daraasada Wax ku oolka ah ayaa lagu saleyn doonaa Qorshaha Hawsha Nadiifinta.
