Dear Dana Bostwick:

The Department of Ecology (Ecology) issued a No Further Action (NFA) determination letter for the Marine Fluid Systems cleanup site on February 3, 2000. The remedy relied on institutional controls (a restrictive covenant) and engineered controls (capping by pavement and buildings to prevent movement of or exposure to hazardous substances).

However, Ecology's 2022 Periodic Review (provided to you on July 29, 2022) concluded that contamination on the adjacent Trident Seafoods property appears to have been impacted by the same common source(s) of contamination as the Marine Fluid Systems property. The Periodic Review also concluded that the selected remedy is not protective of the Trident Seafoods portion of the site.

Therefore, since further remedial action under the Model Toxics Control Act (MTCA) is still necessary elsewhere at the site, Ecology has determined that the February 3, 2000 NFA determination should be rescinded. The effective date of the rescission is the date of this letter.

Next Steps

Ecology will update its database to reflect that Ecology has rescinded the February 3, 2000 NFA determination for this site. The site will be re-listed on the Confirmed & Suspected Contaminated Sites List. The restrictive covenant on the Marine Fluid Systems property remains active and is discoverable through the King County Auditor's Office.
