The Washington State Department of Ecology (Ecology) received and reviewed Boeing's Addendum No. 1 to Pre-Remedial Design Investigation Work Plan, Powder Mill Gulch, Boeing Everett Facility, Everett, Washington dated September 22, 2022. The following conclusions are based on Ecology's review.

Ecology approves the proposed work detailed in Boeing's Addendum No. 1 to Pre-Remedial Design Investigation Work Plan, Powder Mill Gulch, Boeing Everett Facility, Everett, Washington dated September 22, 2022. This work can be performed at the earliest possible time.

Ecology approves the time extension for the submission of the Dynamic Groundwater Recirculation (DGR) Pilot Study Work Plan from November 30, 2022 to December 21, 2022.

Ecology does not approve the time extension requested for submission of the Source Area Enhanced In Situ Bioremediation (EISB) Engineering Design Report (EDR) from December 15, 2022 to March 17, 2023. Please revise the extension request and submit it separately.
