Actions During the Third Quarter 2022

Actions Performed

• A Traffic Control Plan was drafted and included in an informational street use right-of-way (ROW) permit application submitted on December 22, 2021. The ROW permit application was subsequently revised due to other construction activity within the area. The ROW permit application was approved on July 26, 2022.

- A schedule extension request was submitted to Ecology with the August 2022 Monthly Progress Update on September 2, 2022, and approved by Ecology on September 6, 2022. The approval email is included as Attachment 1.
- Drilling is scheduled to begin on November 8, 2022. The updated project schedule is included as Attachment 2.

Sampling and Testing Reports

No sampling and testing or other data reports were received during this reporting period.

Deviations from Approved Work Plans

 The Bank of America property owners have denied access to their property for installation of approved monitoring well CC-MW-05. Therefore, well CC-MW-05 will not be installed and a data gap will remain in this area.

Contacts with Local, State, Federal, or Tribal Representatives

• July, August, and September monthly project updates were submitted via email to Ecology.

Summary of Problems

Problems Encountered

No additional problems were encountered during this reporting period.

Anticipated Problems

 With significant construction throughout the area, access may become more difficult, traffic control may require adaptive management, and further schedule modifications may be necessary.

Solutions to Address Problems

 Anchor QEA will continue to monitor construction activities in the area as the drilling start date approaches.

Changes in Key Personnel

• There were no changes to key personnel during this reporting period.

Fourth Quarter 2022 Planned Work

- Implement the Remedial Investigation Work Plan including the following:
 - Install and develop all proposed monitoring wells (with the exception of well CC-MW-05).
 - Complete the proposed soil borings, sampling, and laboratory analysis.

- Perform the first quarter indoor air and ambient air monitoring event.
- Perform the first quarter groundwater monitoring event.

At your request, this email provides a brief progress update on field work implementation for the Carson Cleaners Site. Below is a summary of progress during August 2022:

Summary of Actions completed during August 2022:

- On behalf of Tahn Associates, please find the attached Schedule Extension Request for your review and consideration. The Schedule Extension Request also includes a revised schedule outlining the installation and monitoring activities throughout the remainder of 2022 through 2023.
- Anchor QEA has scheduled the installation of monitoring wells and complete the proposed soil borings to begin in November 2022. Anchor QEA attempted to schedule drilling sooner with other drilling firms, but there is limited availability throughout the industry.

Summary of Problems:

- Heavy construction in the area presented significant challenges and delays in approval of the ROW Permit.
