This family bought an old Vashon Island store in 1986 from the heirs of the deceased property owner. The facility, now a rental residence had the old storefront façade and the fuel pump in front. While applying for refinance, the bank required the owner to verify the UST was gone but it was not. She spent 4 to 5K sampling with a contractor and removed the tank and 12 cy of PCS but residual soil impacts as gas (510 to 1,500 ppm), B (0.8 to 4.8 ppm), and X (29 to 43 ppm) remained above MTCA. In a letter to Ecology, the owner explained all this and asked for a DNS since her family budget cannot take more
