## DLAIM NTAWV THOV TSO CAI KUAS MUAB LUG KAWM SAIB PUAS YUAV KHU TAU

Lub Washington Department of Ecology taabtom ua dlaim ntawv thov tso cai kuas muab lug kawm saib puas yuav khu tau "Remedial Investigation and Feasibility Study (RI/FS)" rua tug Upriver Dam PCBs kws toj rua huv qaab thu dlej. Qhov kws kawm nuav yog tsom kag rua qhov polychlorinated biphenyls (PCBs) kws nyob ntawm tej khoom qas huv qaab thu dlej xwb. Thaaitsam kws kawm nuav yog pib ze ntawm rivermile (laav) 80 ntawm tug Upriver Dam moog kuas txug rua rivermile (laav) 85 kws nyob rua peg haus dlej ntawm tug Dam kws ze rua ntawm tug Centennial Trail Footbridge. Qhov chaw nuav nyob rua huv Spokane khaustij, Washington (dlaim ntawv qha 1).

Dlaim ntawv thov kuas tso cai nuav yuav yog ib dlaim ntawv cog lug lawv le txuj cai nyob rua nruabnraab lub Ecology, Avista Development, Inc. hab lub Kaiser Aluminum & Chemical Corporation kws yog has txug tej kev ua yog ib feem rua ntawm qhov RI/FS. Dlaim ntawv thov kuas tso cai nuav yuav raug khu le kev tswjfwm kws nyob rua huv Model Toxic Control Act (MTCA) Chapter 70.105D (RCW). Vim tas lub Kaiser taabtom nyob rua huv Bankruptcy (thaus kws tiv nqe ntau kws them tsi taug lawm tes moog thov xaam kuas muab tej nqe kws tiv ntawm lawb pov tseg tuabsis txhaj tsi tau them) mas feem kws lub Kaiser hab lub Avista ua nyob rua huv dlaim ntawv thov kuas tso cai nuav tsuas yog ua tau lawv le lub xaam bankruptcy tebchaws nuav has xwb.

cov dlej kws lug tsso tug Dam kws npau pig vog ntawm saib zoo le caag.



Tomqaab 30 nub kws tso cai rua suavdlawg tawm tswvyim paab rua dlaim ntawv thov kev tso cai nuav taag lawm tes lub Ecology yuav teb tej lug kws puab tau ntawm hab tejzag yuav hloov khu hab, yog tas hum hab zoo yuav.

## Polychlorinated Biphenyls (PCBs)

Polychlorinated biphenyls (PCBs) yog ib cov tshuaj kws peb ua tsi has qhuav qhawv los ua kua. Yog ib cov tshuaj kws tsi muaj xim hlo le los muaj xim dlaaj tshab heev nwg tsi tsw los noj tsi qaab le. Cov tshuav nuav dlhau lug si ua kua fluids hab coolant kws pleev tej tshuab transformers, capacitors los lwm yaam khoom ua suavtawg xob xis le lub xaa suavtawg hab hydraulic fluids, ua kuas cwjmem, ua dclaim ntawv carbonless paper, hab siv rua lwm yaam. Asmesliskas tub tsum tsi ua PCBs rua xyoo 1977 lawm vim tas muab timkhawv qha tas cov nuav nyob rua huv tej khoom ib ncig yug hab yuav ua yug muaj kev mob nkeeg.

Qhov kws ua rua tuabneeg tau cov PCBs huv tug dlej Spokane River nuav yog lug ntawm tuab qhov kws noj cov ntseg nuv tau huv tej thaaj chaw tug dlej nuav xwb. Thaajtsaam kws muaj tej tshuaj nuav tsi tau pum tas muaj teebmeem khi nrug rua tej chaw dlaa dlej kws suavdawg pheej dlaa ntawm le.

Nyob rua nruabnraab xyoo 1978 hab 1984 pum tas muaj PCBs nyob rua huv cov ntseg kws nuv huv tug dlej Spokane River lug kawm. Thaus yuav kawg xyoo 1990 tau rov muaj dlua ib zag kawm hab tseem pum tau tas cov ntseg kws nuv tau tej qhov tseem muaj tshuaj ntaw kawg nyob rua ntawm paub hab.

Tej ntaubntawv kws nyam qhuav kawm tsi ntev nuav ua rua peb paub zoo txug cov PCBs kws nyob rua huv tej khoom qas kws tog rua huv qaab thu dlej hab paub tas PCBs nuav yog lug ntawm thaajtsaam Spokane-area point sources (xws le tej kws nomtswv tso cai rua tej chaw uanum tso tawm moog). Pum tau tas tejzag lub Avista, Kaiser hab Liberty Lake Sewer District yog cov kws ua rua kuas muaj PCBs rua ntawm tug Upriver Dam hab yaav dlhau lug lawm pheej tso

tej dlej qa tawm moog rua huv tug dlej Spokane River.

## Lwm txuj key kawm

Lub United States Environmental Protection Agency (USEPA) huv qaab kev tswifwm ntawm CERCLA (federal Superfund) kuj tau kawm txug tug dlej Spokane River nuav hab. Qhov kws USEPA kawm nuav yog tsom kag rua cov hlau xws le zinc, arsenic, cadmium hab lead kws muaj feem rua kev nrhav nyaj kub dlhau lug lawm kws nyob rua huv lub laav Idaho. Tau muab cov hlau nuav tso ntau heev rua saab sau tug dlej Spokane River tseem muaj ib cov txua moog dlhau thaajtsaam aav mog mog kws lu cov khoom qas huv qaab thu dlej kws nyob rua saab tom qaab tug Upriver Dam qhov kws pum tas muaj PCBs. Tej ntaubntawv txavsb kws lub USEPA (lub Cuaj hlis ntuj tim 2002) tau xaiv yuav qhov kws moog muab npus ca los moog muab khawb tawm lug ua qhov kws ntxuav tej kuas hlau kws nyob rua huv tug Upriver Dam. Tseem tsi tau xaiv yuav qhov kws yuav ua thusa kawg lug ntawm ob qhov kws tau xaiv tseg nuav. Qhov RI/FS kws ua lug ntawm lub Kaiser hab lub Avista nuav npaav tas tejzag yuav tav rua thusa kawg xyoo 2004. Lub USEPA tej hlau RI/FS tub tav lawm tamsis tseem tshuav dlua tej qhov num kws yuav tau ua nyob ze rua ntawm lub Upriver Dam. Lub Ecology npaaj nrhav num ntxiv kws yuav pib ntxuav cov PCBs kws tog rua huv qaab thu dlej ntawm tug Upriver Dam lawv le USEPA kev npaaj tseg.

Tsi taag le nuav xwb lub ecology tseem tsim kuas muaj ib txuj num kws hu ua Total Maximum Daily Load (TMDL) ntsuag saib PCBs kws nyob rua huv tug dlej Spokane River. Qhov nuav yog khu kag cov PCBs hab cov dlej kuas zoo kws tsi yog khu cov PCB kws toj rua huv qaab thu dlej. Yuav muaj ib dclaim ntawv tshaabxu txug TMDL kws tejzag yuav yog thusa xyoo 2004.

Lub Ecology yuav muab taagnrho cov tswv yim kws xau tuaj has txug dclaim ntawv thov kuas tso cai rua qhov PCBRI/FS ntawm lug saib tuab quas zoo tejzag kuj yuav hloov los txwm khu hab. Yuav muaj ib dclaim ntawv xaus lug tuaj teb rua cov tswvyim kws sau tuaj paab ntawm. Nwg nyob rua ntawm lub chaw ca ntawv kws nyob rua ntawm nplooj ntawv saab ib. Thaus kws dclaim ntawv thov zoo lawm hab raug tso cai lug ntawm lub xaam lawm tes le maam pib ua RI/FS nuav kuas tav.
