I'm emailing to provide this quarterly progress update for XS0007 former Elk Plain Road Maintenance Site..

- Description and status of Site characterization or cleanup work (completed during past quarter or ongoing work).
 - IN early February 2023, Herrera completed extensive XRF field screening of suspect contaminated soils in 20 test pits at the Former Maintenance Shop Area. Based on the XRF results and lab data for 6 new lab samples we conclude that there is no further characterization or remediation work needed at this AOC #19. Herrera will be submitting a tech memo within the next two weeks to present the results to Ecology.

 - Herrera will request an opinion on the AOC#19 tech memo that will be submitted this March 2023.
