On December 5, 1990, Washington State Department of Transportation (DOT) and its contractor, Stokes Construction, Inc. of Seattle, WA, began removal of a 2,500 gallon diesel tank at the Bellingham Facility. The tank was removed and excavation and stockpiling of contaminated soil began right away.

Approximately 100 C.Y. were removed and stockpiled on site. On December 6, 1990, three soil samples were taken from the contaminated stockpile. Although one sample had less than 10 ppm, the other samples had 656 and 1,038 ppm as diesel.

On December 13, 1990, five soil samples were taken from the hole where the diesel tank had been. Three of these had results of less than 10 ppm, one at 64 ppm, and one at 252 ppm as diesel. The high reading was on the south side of the hole in a small area of sand. The excavation equipment can only access the hole from the north side and could not reach any further to the south.

This sand pocket was cleaned out when the hole was backfilled. The DOT backfilled the hole January 22, 1991. At the same time, the stockpile of contaminated material was hauled and stockpiled at DOT pit number D-245 about one mile north of Arlington.

Mr. Jim Gunderson, DOT Facilities Engineer for District 1 is preparing a report on the soil remediation program at this location.
