The Washington State Department of Ecology (Ecology) is writing to request available information that you have regarding the R&R Automotive Cleanup Site.

Background

Data from contamination investigations that were conducted on your property was provided to Ecology within a groundwater monitoring report titled "*Groundwater Monitoring Report, Fourth Quarter 2016, TOC Holdings Co*", prepared by Stantec Consulting Services Inc. and dated March 31, 2017. These data indicate that a contamination release(s) has occurred on your property located at 24325 56th Ave W. Ecology understands that more contamination characterization and/or cleanup work may have taken place on your property since that time.

Request

Ecology requests that you provide us with copies of available plans, reports, and data from your property. Currently, Ecology is in discussions with a potential purchaser of the former Time Oil Company (TOC) properties to the north of your property, and data are needed from your property for us to assess the relationship of contamination from the TOC Site and the R&R Automotive Site. A release(s) also occurred on the property to the north of you at 24311 56th Ave W and a separate letter is being sent to Patrick Herman. A map showing the cleanup sites in the area is attached.
