Pursuant to the Model Toxics Control Act (MTCA), Chapter 70A.305 RCW; the Uniform Environmental Covenants Act, RCW 64.70.100; and WAC 173-340-440, the Washington State Department of Ecology (Ecology) has determined, after public notice and comment, that the Environmental Covenant (hereafter "Covenant") filed of record in King County under Auditor File Number 20200513000356 on May 13, 2020, between the City of Bothell as Grantor and Ecology as Grantee or Holder of the Covenant over the property legally described in Exhibit A is no longer necessary under MTCA and its implementing regulations, Chapter 173-340 WAC, to protect human health and the environment and the integrity of the remedial action. Ecology hereby consents to termination and release of the Covenant and relinquishes and quit claims to the City of Bothell any and all rights it may have that were created by the Covenant.



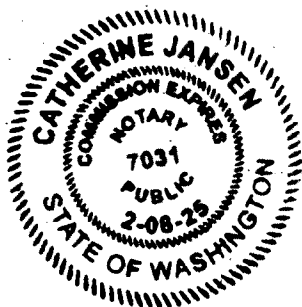
