## Dear Alison McGrane:

Thank you for the draft Access Easement Agreement (Agreement) you provided to Ecology on May 4, 2023. The draft Agreement grants access over and across an existing road (Road). The Road is part of an environmental (restrictive) covenant (Covenant) executed pursuant to the Model Toxics Control Act (MTCA), chapter 70.105D RCW,<sup>1</sup> the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA<sup>2</sup>), chapter 64.70 RCW.<sup>3</sup>

The Covenant restricts certain activities to protect human health and the environment and ensures any cleanup actions remain protective. At this site, mill tailings and other contaminated materials were placed under a cap consisting of 24 inches of clean soil. The Covenant restricts any activity that would compromise the integrity of the soil cap.

Ecology has reviewed the draft Agreement. Our review has determined that the proposed use of the Road **will not** compromise the integrity of the cap. This is because the cap is not located under the Road. Therefore, the activities proposed in the draft Agreement are consistent with the Covenant and do not require modification of the Covenant.

Ecology appreciates the opportunity to review the draft Agreement. Although use of the Road is consistent with the Covenant, we urge caution for the application of loads in excess of the cap load-bearing capacity. Any excessive load placed over and across the soil cap is prohibited. Please ensure that vehicular traffic granted under this draft Agreement is restricted to the Road.
