Proposed Removal of DuPont Corporate Park L.L.C. from an Existing Restrictive (Environmental) Covenant

Site Cleanup

The Washington State Department of Ecology (Ecology) proposes removing 2800 Center Drive North, DuPont, WA ("the Site") from an existing restrictive (environmental) covenant for the Du-Pont Corporate Park site.

The Site is owned by the DuPont Corporate Park LLC ("DCP"). The DCP completed a cleanup of the site under Ecology's Voluntary Cleanup Program. Ecology has determined:

- Lead-contaminated areas of the Site have been cleaned up to meet Model Toxics Control Act (70.105D RCW) standards for unrestricted land use*.
- The Site qualifies for a No Further Action (no further cleanup work is needed).

Site Background

The DuPont Corporate Park is located at 2800 Center Drive N. and consists of four parcels of land. The site was once used as storage for the DuPont Works explosives plant.

The site was also affected by emissions from the former Tacoma Asarco Smelter and by lead paint from old buildings. As a result, some of the soil was polluted with lead—a toxic metal.

Restrictive Covenant

Before 2006, the Site was part of the neighboring Intel property. In 1995, Weyerhaeuser cleaned up the Site to meet **state industrial cleanup standards** and sold it. However, because industrial cleanup standards are not as stringent as **unrestricted land use standards***, a restrictive covenant was placed on the Site.

The Site has been cleaned up to state cleanup standards for unrestricted land use. Ecology proposes removing the Site from the restrictive covenant that covers this and the adjacent Intel properties. The restrictive covenant will remain on the Intel property deed.

Ecology wants your comments!

You are invited to review and comment on the No Further Action Report and Restrictive Covenant. The No Further Action Report describes more about the site history and how it was cleaned up.

Ecology will consider and respond to all public input at the end of the comment period. The restrictive covenant will then be removed.
