The U.S. Environmental Protection Agency, Region 10 has received Baxter's *Workplan for Installation* of Oxygen Infusers and Rehabilitation of Recirculation Trench (Workplan), dated May 2015, submitted by GSI Water Solutions, Inc. by email on May 18, 2015. This Workplan is required under the above referenced Order. The EPA's comments on the Workplan are below.

Page 3, Recirculation trench rehabilitation, paragraphs 3iii, 3iv, 3vi:

References are made to drilling a series of geotechnical borings within the existing trench. Open bottom pipe casings must also be installed in the borings so that the top of the casing is at the bottom of the limestone treatment material in the trench.

Figure 5:

Revise the figure and the legend to show that the crushed rock or gravel will be installed inside of an open bottom pipe casing.

The reason for these changes is that a boring filled with rock or gravel without a casing will not force the water to flow out of the additional limestone treatment material.
