Farallon prepared the following Expedited VCP Fourth Quarter 2023 Progress Report on behalf of Lakeside Industries, Inc. for the Former Asphalt Batch Plant located at 2001 Johnson Road in Centralia, Washington. The Former Asphalt Batch Plant Site was assigned Expedited VCP Project ID XS0014.

- Description and status of Site characterization or cleanup work (completed during past quarter or ongoing work).
 - Farallon conducted a groundwater monitoring event in November 2023. Concentrations of total petroleum hydrocarbons as diesel-range organics and oil-range organics were less than MTCA Method A cleanup levels.

 - No opinion requests are pending at this time.
- Summary of dates and titles of documents submitted to Ecology for review in the last quarter.
 - No documents were submitted to Ecology in the last quarter.
 - Farallon anticipates submitting a Groundwater Monitoring Report and request for No Further Action determination in late December 2023 or early 1Q2024.
