Dear Mr. South:

On behalf of Chevron Environmental Management Company (Chevron), ARCADIS U.S., Inc. (ARCADIS BBLES, formerly known as BBL Environmental Sciences, Inc.) is supervising implementation of the Lower Yard Interim Action at the former Unocal Edmonds Terminal. Mobilization to the site was initiated on July 30, and excavation activities began on August 13, 2007. The start date of the project was delayed due to contracting issues with the contractor selected to perform the work and for the disposal facility, and additional safety training required to assure that the project would be conducted safely and without incident.

Although work at the site has proceeded efficiently since excavation activities were initiated, an increase in the volume of material to be excavated has slowed progress. As of the submittal date of this request, approximately 25,000 tons of soil have been removed from eight of the planned excavations at the site. The original estimate for these eight excavations (based on drawings provided in the Agreed Order), was approximately 18,000 tons. Accordingly, production volumes thus far have been approximately 39% greater than originally estimated

Due to the on-set of winter weather, and the expectation that soil removal will continue to exceed the estimates in the agreed order, an extension to the schedule is respectfully requested Soil excavation activities are expected to last into February 2007, with the following assumptions:

Significant weather delays are not encountered

- Production continues at an average of 1,000 tons/day (fair-weather production is approximately 1,300 tons/day)
- Total soil excavated from the site does not exceed 85,000 tons (approximately 30% higher than the estimate in the agreed order)
- Approximately one week of production will be lost due to the holidays

The requested schedule change will impact monitoring well installations, and subsequent monitoring and reporting events, although the sediment removal activities are still planned for August-September 2008. When possible, remaining site activities will be conducted within the original proposed time frame. The proposed revised schedule is as follows:
