# **Proposed Removal from the Hazardous Sites List Available for Review and Comment**

The Washington State Department of Ecology (Ecology) is proposing to remove the Pacific Pride Tanker Fire site, located at State Hwy 2, Milepost 116 in Monitor, from the Hazardous Sites List (HSL).

The Hazardous Sites List is a list of sites Ecology reviewed for their potential threat to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.

# Site Background

On July 24, 1991, a gasoline tanker spill occurred as a result of an accident in Chelan County near Monitor spilling approximately 10,000 gallons of gasoline. The tanker caught fire and resulted in a portion of spilled fuel being burned.

### **What Has Been Done?**

In 1992, around 1,300 cubic yards of gasoline-contaminated soil was removed and properly disposed of offsite. Water and gasoline in the excavation area were pumped out and properly disposed of offsite.

In 2018, soil sampling revealed no gasoline contamination remained above state cleanup standards. Groundwater sampling conducted between 1996 and 2018 confirmed no contamination remains above state cleanup standards.



## Why This Matters?


Ecology has determined that the site no longer poses a threat to human health or the environment and recommends removing the site from the Hazardous Sites List.

## **What Happens Next?**

After the public comment period ends, Ecology will review and respond to comments received during the comment period. Ecology will hold a public meeting if requested by 10 or more people. If no changes are necessary, the site will be removed from the Hazardous Sites List.
