MEMORANDUM OF AGREEMENT

Owner:

J. R. SIMPLOT COMPANY ("SIMPLOT")

Legal Description:

A portion of the Northwest quarter of the Southeast quarter of Section 8, Township 20 North, Range 24, E.W.M., Grant County, Washington, described as follows:

Commencing at a point on the West line of said Northwest quarter of the Southeast quarter which point is distant 200 feet Southerly (measured at right angles) from the center line of the right of way of the Great Northern Railway Company; thence Southerly along the West boundary line of the Northwest quarter of the Southeast quarter a distance of 200 feet, more or less, to the Southwest corner of said Northwest quarter of the Southeast quarter, thence Easterly along the South boundary line of said Northwest quarter of the Southeast quarter a distance of 210 feet; thence Northerly parallel to the West boundary line of the Northwest quarter of the Southeast quarter to a point which is distant 200 feet at right angles from the center line of the right of way of the Great Northern Railway Company; thence Southwesterly parallel to and distant 200 feet at right angles from the center line of said railroad right of way to the point of beginning. EXCEPTING THEREFROM the West 30 feet of said parcel.

THIS INSTRUMENT, between the parties hereto is hereby given to evidence the existence of a VOLUNTARY GROUNDWATER USE RESTRICTION AGREEMENT ("AGREEMENT") entered into between SIMPLOT and CENEX HARVEST STATES COOPERATIVES ("CENEX") in MAY 13.

WITNESSETH:

- 1. CENEX is performing a Remedial Action to remediate releases of hazardous substances from its facility in Quincy, Washington. A component of such Remedial Action is an AGREEMENT between CENEX and SIMPLOT.
- 2. Pursuant to the AGREEMENT, SIMPLOT voluntarily agreed to restrict use and withdrawal of groundwater on its property in Quincy, Washington, described in the legal description above ("PROPERTY").
- 3. The terms of the AGREEMENT shall be effective as of the date first written above until the AGREEMENT is terminated.
- 4. The AGREEMENT runs with the land and is binding on all parties and all persons claiming under them, including successors and assigns and all current and future owners or lessees of any portion of or interest in the PROPERTY.
