Dear Brett Olson:

The Department of Ecology (Ecology) is terminating the VCP Agreement governing Project No. NW3347. The project involved the cleanup of the Alfys Pizza Container facility (Site). The effective date of termination is the date of this letter. We are providing this notice in accordance with the terms of the Agreement.

Reason

Ecology is terminating the Agreement because we understand that you are not actively cleaning up the Site. On April 11, 2023, we sent you an opinion letter determining that further remedial action is necessary to cleanup contamination at the Site. There has been no communication regarding cleanup activities on the Site; therefore, on January 23, 2024, we sent you a letter requesting an update on the status of your cleanup and your plan for completing the cleanup. You did not respond to that request. Since we have not heard from you, we have decided to terminate the Agreement.

Next Steps

Based on this decision, Ecology may take one or more of the following steps:

- 1. Send you an invoice for any costs remaining on your account. In accordance with the terms of the Agreement, you remain responsible for any costs incurred by us before the effective date of termination.
- 2. Conduct a site hazard assessment (SHA) and rank the Site for further action.

You may apply to reenter the VCP if you decide to conduct further action at the Site.
