Thank you for submitting the final *Cleanup Action Report* dated February 20, 2024 (*CAR*), to document the soil cleanup action at the Seventh Avenue Service facility (Site) at 701 S. Jackson Street, in Seattle, Washington. The soil cleanup action was conducted in accordance with Prospective Purchaser Consent Decree (PPCD) No. 22-2-15886-7 SEA. We have no further comments on the document. Therefore, the *CAR* dated February 20, 2024 is hereby approved.

Ecology appreciates the diligence of 701 S Jackson Partners, LLC and its consulting team in the fulfillment of the requirements of the PPCD. Active soil cleanup at the Site is complete. Site cleanup will proceed to the next steps in accordance with the PPCD and Ecology's *Cleanup Action Plan*, dated September 20, 2022.

Next steps of cleanup action include installation of additional monitoring wells and vapor probes in adjacent rights-of-way, installation of a vapor barrier, performance and confirmation monitoring, and establishment of an Ecology-signed Environmental Covenant. Please keep me informed of any issues as they occur during implementation of the next steps of the cleanup action. We look forward to continued progress at the Site.
