Area of Potential Effect and Project Activities

The Washington State Department of Ecology (Ecology) is overseeing work at the Jeld Wen Cleanup Site. The planned activities include soil and sediment sampling. Ecology and the recipient have completed an Ecology Cultural Resources Form (Form) describing the Area of Potential Effect (APE) and ground disturbing activities (attached).

The project is located at 300 W Marine View Dr Everett, Snohomish County, at T29N, R5E, Section 7, parcel #s 29050700100400, 20950700100500, 20950700100800, 29050700101000, 29050700101200, 29050700400101, and 29050700401900.

Project activities include collecting soil samples across the project area from the surface down to 55 feet below ground surface either by hand, sonic borings, or using a push probe. Sediment samples will be collected using vibracore and will be 3 inches in diameter. Sediment samples will also be collected using a power grab (approximately 24” wide and capable of 1-foot penetration).

Final Determination

Ecology made a preliminary determination that the area is **very high risk** for pre-historic artifacts or other archaeological resources. In the preliminary determination, Ecology recommended the following:

1. An archaeological monitor be present during all sampling.
2. Requirement for an Inadvertent Discovery Plan.

The preliminary determination and request for consultation was sent via email to the following parties on March 22, 2024, indicating a 30-day comment period through April 22, 2024:
