Dear Ziad Youssef:

The Department of Ecology (Ecology) has confirmed that a release of hazardous substances has occurred at the Franklin Street Bellingham facility (Site). This Site requires cleanup under the [Model Toxics Control Act](#) (MTCA),¹ [chapter 70A.305 RCW](#).²

Based on this confirmation, Ecology has added the Site to the [Contaminated Sites List](#).³ This list includes all known contaminated sites that Ecology has determined require further remedial action under MTCA.

Ecology has based this determination on your enrollment in the [Technical Assistance Program](#) (TAP)⁴ of the [Pollution Liability Insurance Agency](#) (PLIA).⁵ We applaud your initiative and appreciate your work to independently clean up the Site.
