Farallon Consulting, L.L.C. has prepared the following Expedited VCP Second Quarter 2024 Progress Report on behalf of The Estate of Barbara J. Nelson and WCN GST Non-Exempt Marital Trust No. 2 for the Thompson Field Gunshy Manor Site (Thompson Field Site) located in the vicinity of 420 196th Avenue NE in Redmond, Washington. The Thompson Field Site is listed with Cleanup Site ID 15285 and was assigned Washington State Department of Ecology (Ecology) Expedited VCP Project ID XN0021.

Below please find the Second Quarter 2024 Progress Report for the Thompson Field Site.

Description and status of Site characterization or cleanup work (completed during past quarter or ongoing work).

- A Nationwide Permit No. 27 was approved by the U.S. Army Corps of Engineers with an effective date of February 25, 2022.
- A Section 401 Water Quality Certification (WQC) was approved by Ecology on April 4, 2024 (WQC Order No. 22549; Corps Reference No. NWS-2023-153).
- A meeting with the King County Hearing Examiner regarding the Clearing and Grading Permit application was conducted on April 15, 2024. The Office of the Hearing Examiner issued a decision approving the Preliminary Plat for Gunshy Manor, subject to revised conditions, on May 30, 2024.

- No documents are currently pending opinion requests from Ecology.

Summary of dates and titles of documents submitted to Ecology for review in the last quarter.

- On April 30, 2024, Farallon prepared and submitted **Compliance Sampling Plan, Thompson Field, King County Parcel No.0825069104, Redmond, Washington** dated April 30, 2024. Ecology approved the **Compliance Sampling Plan** via an email from Frank Winslow to Greg Peters dated April 30, 2024.

- No documents are planned for submittal to Ecology during the next quarter.
