#### Hi Jeremy,

I will need to go through recent correspondence and our NFA Likely letter to recall if there were any other outstanding elements that Ecology had requested prior to issue of NFA. I see that your progress report mentioned a groundwater monitoring summary and submittal of data to Ecology's EIM system. To my recollection, I believe those may have been the last requested elements to be eligible for a property-specific NFA.

Once you believe that you have submitted all of the requested elements, please submit an opinion request (an email would suffice) including whether you are requesting a property-specific NFA or Site NFA. As previously discussed, further action would be needed on the wetlands sediments concern to be eligible for a Site NFA.

Please note that Ecology is not planning to provide an opinion document, per se, on the provided hydrogeological assessment document. Rather, if we do not have further comments on this document, then we will simply include some discussion on this subject within our overall opinion letter. In general, we note that the provided cross sections appear to show that the water table is expected to be well below land surface for both the current and planned grade near the toe of the slope on the property. Ecology would still urge caution in doing grading work near the slope toe, and suggest providing for real-time contingency measures should any seepage be encountered during Site grading work.
