Landau Associates, Inc. (Landau) prepared this progress report for the TECT Aerospace Cleanup site (Site), at the request of the Snohomish County Airport (Airport), to address Snohomish County's obligation under Section VII (C) of Agreed Order No. DE 21781 (AO) to provide progress reports to the Washington State Department of Ecology (Ecology). This report summarizes progress during the first quarter (January through March) of 2024, and activities anticipated for the second quarter (April through June) of 2024.

## The following activities were conducted in the first quarter of 2024:

- Prepared for and conducted the first quarter groundwater elevation survey and updated the existing deep aquifer groundwater elevation contour figure.
- Ongoing coordination with waste disposal vendors to characterize and dispose of existing investigation-derived waste drums currently stored on Site.
- Reviewed Ecology comments on the agency review draft of the Agreed Order Remedial Investigation/Feasibility Study (RI/FS) Work Plan (AO RI/FS Work Plan) and discussed proposed edits during a meeting between Ecology, the Airport, and Landau representatives on March 21,2024.
- Prepared and submitted a technical memorandum summarizing the March 21, 2024 meeting discussion and responses to Ecology comments on the AO RI/FS Work Plan.
- Ongoing preparation of the agency review draft AO RI/FS Work Plan Revision 1.

## The following activities are anticipated for the second quarter of 2024:

- Prepare and submit the AO RI/FS Work Plan Revision 1 to Ecology for approval.
- Prepare the final version of the AO RI/FS Work Plan.

 Prepare for and begin implementing the AO RI/FS Work Plan following receipt of Ecology approval, including coordination with subcontractors, analytical laboratories, and Airport representatives and tenants.

## Deviations from the AO Scope of Work and Schedule:

None to report.
