Dear Greg Vogelpohl:

You are hereby invited to participate in negotiations for completion of a Remedial Investigation, Feasibility Study, and draft Cleanup Action Plan for DeBocks Main Street Texaco (Site)¹ in Grandview, Washington. Ecology anticipates the negotiations will culminate in the signing of an Agreed Order (AO) by willing parties.

Ecology is inviting Potentially Liable Persons (PLPs) to participate in the negotiations. PLPs for DeBocks include (but are not limited to) Powell Distributing, LLC, Chevron USA, and ExxonMobil Corporation.

Groundwater and soil samples collected at the Site have indicated soil and groundwater contamination above Model Toxics Control Act (MTCA)² cleanup levels. Your participation is important since key decisions will be made during negotiations and implementation. If you choose not to participate in negotiations or sign the Agreed Order, you are still deemed to be a PLP by Ecology.

During this meeting, PLPs will have an opportunity to discuss and provide feedback on the draft AO. Please have a written record of any feedback you may have, to leave with Ecology for review following the meeting.
