Hi Shane,

Thank you for your email. Ecology defers to Landau on the locations and amounts of injectate for this third injection round. We assume injection will be taking place upgradient of all locations that had cleanup level exceedances in the last sampling round.

We look forward to the sampling results following the third injection round. We concur with waiting a period (not to exceed one year) following injection to sample the monitoring wells in order to allow for complete ISCO treatment as well as allow for any potential rebound. We request during that round to include field measurement and reporting of dissolved oxygen (DO) and oxidation-reduction potential (ORP) in order to provide some additional information of the longer-term effect of the ISCO on the aquifer geochemistry.

The need for additional post injection monitoring rounds will be assessed by Ecology following review of the post injection monitoring round, as well as following any subsequent events, since sufficient data to support a No Further Action (NFA) determination will be determined by Ecology following review of the data. There may also be potential to adjust locations for continued monitoring following monitoring events.

A brief technical memorandum could be prepared to summarize the injection work following injection. Once Ecology has reviewed the post-injection monitoring data, we can assess final reporting needs. We anticipate that preparation of a remedial action completion report summarizing the three injection rounds and monitoring could follow Ecology's determination of sufficient monitoring to support a NFA determination.

Frank,

Thank you again for discussing the third ISCO injection round at Tiger Oil North First Street. The third ISCO injection is planned to be focused on:

- Locations at the site where gasoline range organic concentrations in groundwater were above MTCA Method A CULs following the second injection and
- Locations on the upgradient edge of the site, including the location of the highest preinjection groundwater concentration (IW-18) to prevent rebound and promote contact with any remaining downgradient contamination.

We intend to inject 2,500 gallons of Klozur One (the same ISCO product and volume per well used in the previous two injections) into each of 10 injections wells IW-3, IW-8, IW-6, IW-15, IW-7, and IW-16 (on the eastern/downgradient area of the site where the highest concentrations remained following the second injection) as well as injection wells IW-2, IW-4, IW-10, and IW-18 (on the western/upgradient edge of the site).

The injection is currently planned to be conducted in late September. Post-injection groundwater performance sampling will take place up to one year following the injection to allow for the complete ISCO treatment period and allow for any potential rebound. As applicable to demonstrate compliance with cleanup standards, groundwater may be monitored quarterly for up to two years following the post-injection monitoring event.

Also, we had anticipated providing Ecology with an interim action report describing the monitoring well replacement, injection well installation, injection activities, and groundwater monitoring results following the three injection events. Would you prefer that this report is instead provided following additional quarters of monitoring?

Hi Bill,

I had made a request for the City to inquire with the purchaser regarding a potential environmental covenant (EC) on the Property. I did not receive any reply as to whether or not this was done. I understand that there has been some discussion between the City and Ecology's Section Manager. I have seen nothing in writing from Ecology that we concur with a third injection round. I am not of the opinion that there is a strong likelihood of a third injection round achieving Model Toxics Control Act (MTCA) cleanup levels in a relatively short timeframe. Rather, I do anticipate that cleanup levels will be achieved at the Site via natural attenuation, but over a relatively long period of time. A third injection round should shorten this timeframe. It may significantly shorten this timeframe, but it still could be an extended period of time, based on the observed responses to date.

Note that there are uncertainties with ISCO since there may be natural processes that may compete with the remaining petroleum for oxidation demand. Hence the performance of ISCO can vary from site to site. I would not likely concur with a <u>fourth</u> injection round, since there is likely a diminishing return and the costs may be disproportionately high relative to incremental benefits.

I am still requesting feedback as to whether or not the purchaser was contacted regarding a potential EC on the property. Restrictions on such an EC would include a prohibition on drinking water wells on the Property and a requirement to notify Ecology prior to conducting intrusive work within the area of remaining contamination. The purchaser may, or may not be resistant to such an EC, but it is certainly worth asking them.

I look forward to the City's response.
