Dear Ricka Gerstmann:

The Department of Ecology (Ecology) has confirmed that a release of hazardous substances has occurred at the California Ave Gas Station facility (Site). This Site requires cleanup under the <u>Model</u> <u>Toxics Control Act</u> (MTCA),¹ <u>Chapter 70A.305 RCW</u>.²

Based on this confirmation, Ecology has added the Site to the <u>Contaminated Sites List</u>.³ This list includes all known or suspected contaminated sites that Ecology has determined require further remedial action under MTCA.

Ecology based this determination on your planned enrollment in the <u>Technical Assistance Program</u> (TAP)⁴ of the <u>Pollution Liability Insurance Agency</u> (PLIA).⁵ We applaud your initiative and appreciate your work to independently clean up the Site.

Your cooperation to clean up the Site is neither an admission of guilt nor liability. This notice is required under Washington Administrative Code (WAC) <u>173-340-310</u>(6)(b).⁶
