Dear Kris O'Bannon:

The Washington State Department of Ecology (Ecology) sampled your property as part of our Leaking Underground Storage Tank (LUST) Assessment Program. We are providing an opinion on the work that was done under the authority of the Model Toxics Control Act (MTCA), Chapter 70A.305 RCW.¹

Site Description and History

The Bekins Moving & Storage Company site (Site) is located at 1891 N 1st Street in Yakima, Washington. Petroleum contamination was discovered in 1990 during the removal of one 1000gallon gasoline tank. Gasoline, benzene, and xylene in concentrations greater than MTCA Method A cleanup levels (CULs) was discovered in soil around the tank. Approximately 250 cubic yards of contaminated soil was excavated and moved onsite to be land-farmed during a March 1991 cleanup, during which all contaminated soil was removed.

Soil from the onsite land-farm was resampled in 1998 and contamination greater than Method A CULs was not present.

Ecology issued a Letter of Partial Sufficiency in 2006 for the work that had been done characterizing and remediating contamination in soil.

However, the cleanup actions performed at the Site were not sufficient to meet MTCA's substantive requirements for characterizing potential contamination in groundwater and insufficient groundwater data prevented the Site from obtaining a No Further Action determination.

Site Assessment

In December 2023, samples were collected to determine if contamination related to the historic release of petroleum from the UST was present in groundwater at the Site.

Groundwater samples were collected at the release area and downgradient of the release area and analyzed for the following contaminants: gasoline, diesel, and oil range petroleum hydrocarbons, BTEX, naphthalene, ethylene dichloride, methyl tert-butyl ether, ethylene dibromide, and lead.

Contaminants were either not detected or were detected at concentrations less than MTCA Method A CULs in soil and groundwater.

Opinion

Ecology has determined that no further remedial action is necessary to clean up petroleum hydrocarbon contamination at the Site. As a result, **Ecology is issuing a No Further Action (NFA)** determination for the Site. This conclusion is based on the following:

- Decommissioning and removal of the original, onsite UST has removed the source of petroleum hydrocarbons and related constituents.
- Remedial excavation was used to remove the contaminated soil, which was successfully land-farmed on site.
- Concentrations of petroleum hydrocarbons and related constituents were not detected in groundwater samples, collected at the Site in December 2023, above MTCA Method A CULs.

Limitations of the Opinion

Opinion does not settle liability with the state

Liable persons are strictly liable, jointly and severally, for all remedial action costs and for all natural resource damages resulting from the release or releases of hazardous substances at the Site. This opinion does not:

- Resolve or alter a person's liability to the state.
- Protect liable persons from contribution claims by third parties.

To settle liability with the state and obtain protection from contribution claims, a person must enter into a consent decree with Ecology under RCW 70A.305.040(4).¹⁰
