Haley & Aldrich, Inc. (Haley & Aldrich) prepared this Third Quarter 2024 Progress Report to summarize activities completed between July and September 2024 and anticipated activities between October and December 2024 at the Simplot Facility located at 1800 W. 1st Street, Warden, Washington 98857 (Site). The J.R. Simplot Company (Simplot) entered into Agreed Order (AO) Number DE 16890 with the Washington State Department of Ecology (Ecology) on 7 May 2020 to implement the selected remedy for the Site in accordance with the May 2020 Cleanup Action Plan.

The AO requires Simplot to submit monthly progress reports to Ecology documenting the following activities completed during the previous month:

- A list of on-site activities conducted during the reporting period;
- Detailed description(s) of deviations from required tasks not otherwise documented in project plans or amendment requests;
- A description of scope of work and schedule deviations during the reporting period and any planned deviations in the upcoming reporting period;
- A plan for recovering lost time to maintain compliance with the overall schedule;

- Upload raw data (including laboratory analyses) received by Simplot during the reporting period to Ecology's Environmental Information Management (EIM) database and an identification of sample sources, as applicable; and
- A list of deliverables for the upcoming reporting period, if different from the schedule.

In December 2023 Ecology agreed to reduce reporting frequency to quarterly.

## Third Quarter 2024 Activities

- Haley & Aldrich completed groundwater compliance monitoring at the Site on 21 and 22 August 2024.
- Haley & Aldrich received and reviewed analytical data from compliance groundwater monitoring completed on 21 and 22 August 2024.
- Haley & Aldrich began preparing a Semiannual Groundwater Monitoring Report. The Semiannual Groundwater Monitoring Report will summarize field activities completed in August and analytical results from groundwater samples collected.
- Haley & Aldrich began preparing a Monitoring Well Installation Work Plan to guide installation of additional monitoring wells at the Site.
- Simplot provided Ecology written comments to the Draft Cleanup Action Plan Amendment 1 dated 15 July 2024.

## **Anticipated Activities for Fourth Quarter 2024**

- Haley & Aldrich anticipates providing a Final Semiannual Groundwater Monitoring Report to Ecology for review.
- Haley & Aldrich anticipates providing a Final Monitoring Well Installation Work Plan to Ecology for review.
- Haley & Aldrich will upload analytical data from the August 2024 groundwater compliance monitoring event to Ecology's EIM database.
