## Dear Janice Horton:

The Department of Ecology (Ecology) has reviewed the *Final Basewide Site Inspection Addendum Report for Munitions and Explosives of Concern at Naval Base Kitsap Bangor* (Tetra Tech, June 2024). Ecology **concurs** with the United Sates Navy (USN) no further action (NFA) determination for the following sites:

UXO 02 (Site CC)	UXO 13 (Site 4)
UXO 08 (Site NN)	UXO 14 (Site JJ)
UXO 09B (Site B)	UXO 15 (Site KK)
UXO 10 (Site 12)	UXO 17B (Site 1)
UXO 11 (Site 14)	UXO 17C (Site BB)
UXO 11B (Site 8)	UXO 17D (Site 13)
UXO 12 (Site HH)	

The referenced report, which documents inspections of the sites listed above, identified no MEC or material potentially presenting an explosive hazard (MPPEH) at either the surface or subsurface.

During the preparation of the Quality Assurance Project Plan (QAPP)<sup>1</sup>, additional document research led to the exclusion of UXO 09B (Site B) and UXO 17D (Site 13) from the site inspection (SI) field investigation.

An earlier Phase 1 SI Report<sup>2</sup> was reviewed by Ronnie Johnson in October 2023, and he agreed with its findings. Michael Cronin, the Interim Site Manager, has also reviewed both SI reports and supports the Navy's conclusions.
