#### Yakima Training Center PFAS Response Quarterly Update (Q3 – March - June 2023)

### **Activities Conducted:**

- Eight (8) boundary bedrock monitoring wells were installed between 30 March and 24 April 2023.
- Groundwater sampling of the eight (8) newly installed boundary wells was completed from Monday to Thursday, 22-25 May 2023.
- Preliminary data from the low-flow boundary well sampling event was received on Monday, 26 June 2023. The finalized analytical report is pending.
- Analytical results from the boundary well grab samples were received on Monday, 05 June 2023. These analytical results will be incorporated into the decision logic of the Remedial Investigation (RI) UFP-QAPP.
- RI UFP-QAPP is in progress; the target submission date for a final document is 29 September 2023.
- Off-Installation sampling was conducted at forty-nine (49) locations. Forty-five (45) were split samples with the US EPA. Estimated date for validated data is 25 July 2023.
- Environmental Data Management System funded and in development specific for YTC.
- Assessed individual properties for Point of entry treatment systems (POET) design and installation(s). These are customized systems based on each property's site conditions.
