# **Activities Conducted:**

- Data in review for Remedial Investigation (RI) Mobilization #1:
  - 11 surface water & sediment locations
  - o 48 soil locations
  - Nine (9) new monitoring wells
- Eight (8) boundary monitoring wells sampled
- USGS collected geochemical data and depth to water measurements, 8-12 January 2024
- Off-Installation PFAS sampling was conducted at fifty (50) locations, 16-21 March 2024
- General Chemistry samples collected at seven (7) properties for POET system design
- Rights of Entry (ROE) were fully executed for 33 properties as of 2 April 2024
- Assessment of Class B Water Supply Systems completed 10-11 January 2024. Contract to be awarded in late spring or early summer 2024
- Seventeen (16) POET systems have been installed as of 2 April 2024
- 180 POET performance monitoring samples have been collected to document filtration efficacy; recent validated data indicates systems are generally preforming in accordance with design parameters
- All recently collected data resides in the Environmental Data Management System
