### Periodic Reviews

This site was previously cleaned up under the Model Toxics Control Act (MTCA).

When the site was cleaned up, some contamination was left behind. Institutional controls are measures that limit or ban activities that might cause exposure to this contamination. At this site, a restrictive covenant lists rules to restrict site use and prevent people from being exposed to the contamination.

The Washington State Department of Ecology (Ecology) conducts periodic reviews to make sure the institutional controls remain effective, and the cleanup still protects human health and the environment. Ecology conducts periodic reviews about every five years after visiting the site and reviewing monitoring data.

Periodic review reports are published on the <u>cleanup site webpage</u><sup>2</sup> when they are available. To view and download documents from the cleanup site webpage, scroll down to the "Documents" subheading and open the drop-down menu.

Ecology will hold a 30-day public comment period for the public to provide input on periodic review reports for this site. Ecology announces public comment periods for periodic review reports using the following methods:
