Dear Kevin Smith (Project Coordinator),

This work is being done under Agreed Order No. DE 16955 between Washington State Department of Ecology (Ecology) and the City of Tacoma, Department of Public Utilities, Light Division (d.b.a. "Tacoma Power") and in compliance with the Model Toxics Control Act, Chapter 70A.305 RCW.

Ecology requests that a natural background study be performed at the above referenced site in order to complete the Public Review Draft of the Remedial Investigation Report. As discussed in a October 1, 2024 meeting between Ecology, Tacoma Power, and Tacoma Power's consultant (Haley Aldrich), the current literature study used to eliminate copper as a containment of concern is inadequate. The natural background study shall be conducted in accordance with Washington Administrative Code 173-340-709 and other applicable regulations.

To facilitate the addition of a natural background study and its related documents, Ecology has put together a brief list of anticipated deliverables and their due dates. These deliverables and due dates are intended to supplement the Schedule of Deliverables in Exhibit C of Agreed order No. DE 16955 (Agreed Order). The following schedule is intended to occur between Tasks 8 and 9 of Exhibit C of the Agreed Order. A schedule of anticipated deliverables can be found below:
