Dear Jae Park:

The Department of Ecology (Ecology) has confirmed that a release of hazardous substances has occurred at the Boulevard Grocery facility (Site). This Site requires cleanup under the Model Toxics Control Act (MTCA), chapter <u>70A.305</u> RCW,¹ and the cleanup regulations adopted under that Act, chapters <u>173-340</u>² and <u>173-204</u> WAC³ (collectively called "the state cleanup law").

Based on this confirmation, Ecology has added the Site to the <u>Contaminated Sites List</u>. ⁴ This list includes all known or suspected contaminated sites that Ecology has determined require further remedial action under MTCA.

Ecology based this determination on your December 2024 enrollment in the <u>Technical</u>

<u>Assistance Program</u> (TAP)⁵ of the <u>Pollution Liability Insurance Agency</u> (PLIA).⁶ We applaud your initiative and appreciate your work to independently clean up the Site.
