The Department of Ecology (Ecology) appreciates your decision to clean up the Jackpot 352 facility (Site) independently. Our records indicate that while the Site remains active in the Voluntary Cleanup Program (VCP), you have not submitted a formal request for an opinion on your work plan or Site cleanup since October 22, 2019. This letter requests information on the status of your cleanup and your continued interest in the VCP.

Currently, the Site is on the VCP's [Waitlist - Existing](#)<sup>1</sup>. To expedite removal from the waitlist and move your project forward, we encourage you to submit a [Request for Opinion](#)<sup>2</sup>. Once received, we will assign a cleanup site manager to support you in continuing to clean up the Site.

1. A formal opinion request specifying your cleanup goals and/or work plan.
2. Any available reports or documentation related to Site cleanup status.
3. Plan and schedule for completing the cleanup.

If you respond with a request for an opinion on Site documents, Ecology will assign you a cleanup site manager. Ecology recognizes that due to the holiday season, there may be delays in response times. As such, if no response is received within 45 days, we will proceed with the termination your existing VCP Agreement. You may reapply to the VCP in the future if you conduct further work at the Site. We will notify you of our decision in writing.
